The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM, 2076/12/07 at the office of **Panchkhal Municipality**. Bids must be valid for a period of 90 days after bid opening with scanned copy of the bid security in .pdf format, amounting to a minimum of 78,000/-, which shall be valid for 30 days beyond the validity period of the bid.
6. If the bid opening date falls on a government holiday, then the next working day shall be considered as the bid opening date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
