6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 PM, 2076/09/02 at the office of Panchkhal Municipality. Bids must be valid for a period of 90 days after bid opening with scanned copy of the bid security in .pdf format which shall be valid for 30 days beyond the validity period of the bid.
